SIDEWALK ALONG SR-227 FROM GERALDINE HIGH SCHOOL TO SR-75 – PROJECT NO. SRTS-TAPNU-TA24(904)

THE BRACKET ESTIMATE ON THIS PROJECT IS FROM 600,000 TO 700,000. THIS BRACKET RANGE IS PROVIDED ONLY AS A GENERAL INDICATION OF A BROAD FINANCIAL SIZE CATEGORY FOR THE PROJECT. IT SHOULD NOT BE USED IN PREPARING A BID, NOR WILL IT HAVE ANY BEARING ON ANY DECISION TO AWARD THE CONTRACT. THE PRINCIPAL ITEMS OF WORK ARE APPROXIMATELY AS FOLLOWS:

SIDEWALK ALONG SR-227 INCLUDING CLEARING AND GRUBBING, 8 EA REMOVING TREES, 600 CY BORROW EXCAVATION, 670 TONS CRUSHED AGGREGATE, SECTION 825, TYPE B, 150 TONS COARSE AGGREGATE, SECTION 801, FOR MISCELLANEOUS USE, 124 LF 18" AND 24" ROADWAY PIPE, 176 LF OF 15", 18" AND 24" SIDE DRAIN PIPE, 50 TONS SUPERPAVE BITUMINOUS CONCRETE WEARING SURFACE LAYER, PATCHING, 1 LS PEDESTRIAN BRIDGE, 30 LF 8" AND 12" TRENCH DRAIN, MOBILIZATION, 126 TONS LOOSE RIPRAP, CLASS 2, 1,579 SY CONCRETE SIDEWALK, 4" THICK, 958 SY CONCRETE DRIVEWAY, 6" THICK, 56 SF DETECTABLE WARNING SURFACE, 24 SY CURB RAMP, 10 EA PIPE END TREATMENTS, 4 CY MINOR STRUCTURE CONCRETE, 1 EA JUNCTION BOX, TYPE 1, 100 LF STEEL BEAM GUARDRAIL, CLASS A, TYPE 2, 2 EA GUARDRAIL END ANCHOR, TYPE 20 SERIES (MASH), 12 LF STEEL BEAM GUARDRAIL FOR CULVERT, CLASS A, TYPE 2, CASE 3, 100 CY TOPSOIL, 122 SY SOLID SODDING (BERMUDA), EROSION CONTROL ITEMS, 2,000 LF CONSTRUCTION SAFETY FENCE, GEOMETRIC CONTROLS, 239 SF TRAFFIC CONTROL MARKINGS, CLASS 2, TYPE A, 239 SF TEMPORARY TRAFFIC CONTROL MARKINGS, TRAFFIC CONTROL ITEMS AND RELATED ITEMS.

THE ENTIRE PROJECT SHALL BE COMPLETED IN NINETY (90) WORKING DAYS.

A CASHIER'S CHECK (DRAWN ON AN ALABAMA BANK) OR BID BOND FOR 5% OF THE AMOUNT BID (MAXIMUM OF \$10,000.00) AND MADE PAYABLE TO THE TOWN OF GERALDINE MUST ACCOMPANY EACH BID AS EVIDENCE OF GOOD FAITH. IT IS NOT REQUIRED THAT A CONTRACTOR BE LICENSED IN ORDER TO SUBMIT A BID; HOWEVER, PRIOR TO AWARD OF A CONTRACT, PROPER PROOF OF ALL APPLICABLE LICENSURES MUST BE PROVIDED BY THE CONTRACTOR. PROOF OF INSURANCE COVERAGES OF THE TYPES AND AMOUNTS AS SET FORTH IN THE PROJECT SPECIFICATIONS WILL BE REQUIRED OF THE CONTRACTOR, AND ANY AND ALL SUBCONTRACTORS, PRIOR TO BEGINNING WORK. THE CONTRACTOR WILL BE REQUIRED TO PERFORM WORK AMOUNTING TO AT LEAST 30% OF THE TOTAL CONTRACT COST WITH HIS OWN ORGANIZATION.

CONTRACTOR PREQUALIFICATION IS NOT REQUIRED TO BID ON THIS PROJECT. HOWEVER, THE AWARD OF THE CONTRACT WILL NOT BE MADE TO ANY BIDDER WHO, AT THE TIME OF THE AWARD, IS CONSIDERED BY THE ALABAMA DEPARTMENT OF TRANSPORTATION (ALDOT) TO BE DISQUALIFIED FROM BIDDING, NOR TO ANY BIDDER WHO IS AN AFFILIATE OF OR HAS A CORPORATE OFFICER, DIRECTOR, OR PRINCIPAL OWNER WHO IS A CORPORATE OFFICER, DIRECTOR, OR OWNER OF, ANOTHER PERSON WHO IS PRESENTLY DISQUALIFIED BY ALDOT. FURTHER DETAILS AND DEFINITIONS REGARDING THIS PROVISION ARE INCLUDED IN THE PROJECT SPECIFICATIONS.
